1. Call to Order and Attendance
  
2. Approval of Agenda
  
3. Approval of Minutes from 2014 Annual General Meeting  
One correction: the registration fees for the men's team were to have included transportation to thee away games. It was only necessary to provide transportation to two games.
  
4. Business Arising from 2014 Minutes  
No business arising from 2014 Minutes  
Motion made by Rob Brouwer to approve 2014 Minutes. Motion seconded by Brett Moxley. Carried.
  
5. Reports
  - i. President  
In addition to his report (attached), Rob advised that the club received a certificate of achievement from Rugby Ontario for contributing eleven players to the rep program
  
  - ii. Treasurer  
Dennis Newman had previously sent his regrets and was not present. It was pointed out that the financial statements provided are unaudited due to cost.
    - a) John Carr questioned item 5085 – property expenses for \$7,328.31. Brett Moxley suggested that this item referred to the exterior lights.
    - b) Item 6001 - Clubhouse for \$41,026.68  
John Carr suggested that this item referred to the clubhouse roof.
    - c) The \$74,000.00 under Liabilities and Net Assets include the club mortgage and loan

- iii. Registrar
  - John Carr explained that the “unique” registrations referred to in his report meant individual registrations as some club members have more than one role within the club (ie: player and coach)
  - Flag rugby allowed the club to have more votes with Rugby Ontario (the maximum is 6)
  - The name on the credit card which has been used for registration has been changed from John Carr to Dennis Newman
  
- iv. Property
  - A Facilities Manager is required
  - There are several confirmed bookings for 2015 at this point.
  
- v. VP Game – all team reports
  - The report by Ben Thompson for the U14 team was not handed in
  - The report for the Women’s U18 team was not handed in
  - Kirk Wilson has advised that he is resigning from coaching the women’s team after seven years.
  - It is intended for the club to coordinate flag rugby in 2015. The August session in 2014 had all new players. Paul Steffler will coordinate and Tom Jeffrey will assist.
  - Steve Lamb suggested that U12 girls be encouraged to play with the Peterborough Pagans
  - Sherman Gowan hopes to once again have pre-season training for the U16 girls
  - U16 7’s – huge potential – a club player, Evan Whiteford, made the Blues program and is travelling to Las Vegas
  - A late report for the Women’s team was handed in by Kirk Wilson who advised that the team had a record of 0 wins and 10 losses.
  - Luke Gledhill suggested that we heavily promote the home games for the Over 35 team within club membership. There are only two home games per season and the bar from these games has been profitable in the past
  - Brett Moxley offered to make a sled for the Men’s team
  - Luke Gledhill stated that the Men’s team should be called on to help around the club. Brett Moxley and Rob Brouwer advised that everyone who had been asked in the past had been willing to help. However, Rob confirmed that there would be a void left by the resignation of John Carr and it would need to be filled.

Motion made by John Carr to approve all reports. Motion seconded by Dave Beukeboom. Carried.

8. Dues for 2015
